# *Balabanyts A.V.* EFFICIENCY ASSESSMENT OF MARKETING INTERACTION INTEGRATED MANAGEMENT SYSTEM ON THE BASIS OF DEA TECHNOLOGY. //Economy and Management.-2010.- 6.-P.8.

The article reveals the essence of DEA method and suggests the technology of its deployment for efficiency assessment of marketing interaction integrated management system of enterprises based on the output-oriented model. The author has established the ways to increase efficiency of the investigated enterprises on the basis of the results of the research conducted with the use of the introduced method.

# *Byzyanov E.E.* OPTIMIZATION OF DYNAMICS OF INFORMATION SYSTEM REENGINEERING. //Economy and Management.-2010.- 6.-P.13.

This article describes the process of a company information system reengineering in dynamics. The author has offered a dynamic model of reengineering, which takes into account the main stages of the changes: analysis, decision making, implementation and introduction. It has been established that ensuring optimal dynamic processes of reengineering is impossible without the following three conditions: system stability, minimization of lags and maximization of the effectiveness of performing operations.

# *Bogacheva A. V.* METHODS OF REFLECTING THE PRODUCT QUALITY AND ITS LEVEL IN PLANNING, ASSESSMENT AND CALCULATION OF EXPENDITURES. //Economy and Management.-2010.- 6.-P.28.

The author expounds the main methodical approach to the determination of the technological influence on the quality and standard of the production. The author has offered a new method of allocation of indirect costs in proportion to the volume of the production in consuming units.

# Butuk A. I. THE NATURAL BASIS OF NORTH-EURASIAN INTEGRATION PROTECTIONISM. //Economy and Management.-2010.- 6.-P.34.

The article gives arguments for the necessity to take into consideration the acutely continental climate and enormous distances of North Eurasia when determining the external economic strategy for CIS states, including Ukraine. The author proves the need to strengthen protectionism in relation to far abroad on the one hand and on the other hand – to promote North-Eurasian reintegration process through expansion of the Customs union, formation of common free market zone and creation of monetary union at a later date.

# *Pavlov* . *I.* INSTITUTIONAL PROVISION OF COMPREHENSIVE DEVELOPMENT OF RURAL TERRITORIES OF UKRAINE . //Economy and Management.-2010.- 6.-P.38.

The article reveals discrepancy between the structure of public institutions, «rules of the game» which they follow and the conditions of development and public purpose of rural territories as being structurally complex, multilevel and multifunction object of management. The necessity of reorganization of the applicable administrative structure and development of consolidated state policy aimed at comprehensive development of these social-spatial formations has been grounded.

### *Uskov I.V.* ASSESSMENT OF FINANCIAL STANDING AND QUALITY OF FINANCIAL MANAGEMENT OF LOCAL ADMINISTRATION. //Economy and Management.-2010.- 6.-P.44.

The article systemizes methods of assessment of local financial management quality. Special system of indicative indexes for the assessment of financial standing and quality of financial management of local authorities for Ukraine has been developed and offered.

## *Tsarenko N.V.* METHOD OF ALLOCATION OF COSTS FOR CORPORATE CULTURE ACTIVITY. //Economy and Management.-2010.- 6.-P.51.

The author has formulated basic methodical approaches to allocation of costs for the corporate culture of manufacturing enterprise within the framework of the fixed budget on the basis of efficiency of measures of corporate culture.

# *Berezhnaya I.V., Mihurinskaya K.A.* BASES OF ECONOMIC DOCTRINE OF DEVELOPMENT OF THE SOCIALLY ORIENTED ECONOMY OF AUTONOMOUS REPUBLIC OF CRIMEA. // Economy and Management.-2010.- 6.-P.57.

The article views approaches to the determination of principles of regional policy, which will make it possible to select basic strategic directions of economic doctrine of socially oriented economy of AR Crimea. The author gives substantiation of target and main principles of realization of economic doctrine of the socially oriented economy, which will provide the ability to create conditions for achievement of economic security of the regional public system.

*Boychenko E.B.* SPECIFICS OF POPULATION AGEING (BY THE EXAMPLE OF DONETSK REGION). //Economy and Management.-2010.- 6.-P.63.

The low birth rate, which doesn't provide the simple reproduction of population, the high death rate, especially at working age, and negative balance of migration cause the reduction of population size in Donetsk region resulting in the narrowed type of reproduction, the consequence of which is an increase of the percent of those who are older than working age in population structure. Taking into account the existing dynamics of demographic processes, measurement and structure of migration flows, it is likely that for this region the expansion of those negative processes like depopulation and population ageing will be typical.

The present state of environment in Ukraine has been studied. The anthropogenic factor, economic damage from pollution of the environment of Ukraine, its regions and European countries has been estimated. The main economic activities causing the biggest damage to environment have been determined. Financing of the environmental protection has been investigated.

# *Shevchuk O.I.* PROBLEMS OF BIRTH RATE: NEGATIVE INFLUENCE OF ECOLOGICAL SITUATION. //Economy and Management.-2010.- 6.-P.97.

The author has considered influence of economic situation on birth-rate and outlined possible consequences of such influence. Measures aimed at the improvement of situation have been offered.

# *Vasilenko E.V.* ASSESSMENT OF STRUCTURAL CHANGES IN THE ECONOMY OF DONETSK REGION. //Economy and Management.-2010.- 6.-P.102.

The basic theory aspects of crisis management have been allocated. Differentiations of crisis management conception according to scale and time have been offered. Methods of crisis diagnosing at an enterprise have been defined. Signals of oncoming crisis at an enterprise and possible ways to minimize their influence have been described.
