Optimization of enterprises' capital structure through the use of operating and financial leverage has been carried out. It has been established that the price of borrowed funds of industrial enterprises is somewhat lower than that of internal funds, and that is why there is an optimal capital structure that minimizes their weighted average price and maximizes qualification of an enterprise. The limits of the maximally cost-effective and minimally risky capital structure make it possible to determine the right choice of its specific values for the planning period. The author has determined that critical sales volume and constant expenses of industrial enterprises grow at the cost of cost-effectiveness of internal funds, leverage ratio. A conclusion has been made that the reasonableness of the capital structure ratios, assessment of their dynamics can be established through long-term comparisons of groups of related businesses.
